

WANDERFULL TALES TERMS & CONDITIONS

1. Introduction

Welcome to Wanderfull Tales. These Terms and Conditions govern your use of our services, including participation in our retreats. By booking all Wanderfull Tales retreats, you acknowledge that you have read, understood, and agreed to these terms.

2. Retreat Details

2.1. Retreats may take place at various locations and on different dates. Specific details for each retreat, including location, accommodation, and timings, will be shared prior to booking.

2.2. Where accommodation is provided for the duration of the retreat participants agree to stay in the accommodation provided and may not bring outside guests unless expressly permitted by Wanderfull Tales.

2.3. Arrival and departure timings will be communicated once the participant list has been finalised for each retreat.

3. Booking and Payment

3.1. All bookings are subject to availability and confirmation.

3.2. Full payment is required at the time of booking to secure your place.

3.3. Prices are listed in GBP (£) and are subject to change without prior notice.

4. Cancellation and Rescheduling

4.1. Wanderfull Tales does not offer refunds for any reason.

4.2. If a participant cannot attend, they may resell their ticket. Wanderfull Tales will support resale efforts by sharing on social media but is not responsible for the resale process.

4.3. If a retreat is cancelled or rescheduled by Wanderfull Tales, participants may choose to attend the rescheduled retreat or receive a credit toward a future retreat. No cash refunds will be provided.

4.4. In case of force majeure (see Section 10), Wanderfull Tales reserves the right to cancel or reschedule retreats without liability for any losses incurred by participants.

5. Travel and Insurance

5.1. Participants are responsible for arranging their own travel, including flights and transfers. Transfer services may be offered but are subject to availability for each retreat.

5.2. Participants are responsible for researching, sourcing, and paying for any necessary visas required for entry into the country of the retreat.

5.3. Wanderfull Tales does not provide travel or health insurance. Participants are strongly advised to obtain appropriate insurance cover for the duration of the retreat.

5.4. Wanderfull Tales is not responsible for travel disruptions, including flight cancellations, visa issues, delays, or personal travel arrangements.

6. Participant Responsibilities

6.1. All activities are undertaken voluntarily. Activities may occur on land, in water, or on the beach, depending on the retreat program.

6.2. Participants are responsible for their own health and safety during the retreat. Wanderfull Tales is not liable for any injuries, accidents, or illnesses that occur during the retreat.

6.3. Any personal belongings brought to the retreat are the participant's responsibility. Wanderfull Tales is not liable for lost, stolen, or damaged items.

6.4. If any equipment provided by Wanderfull Tales, or any property within the retreat venue (such as venue's furniture or other facilities), is damaged by a participant, the participant responsible will be required to cover the full cost of repair or replacement.

6.5. Participants must adhere to local laws and regulations during the retreat.

6.6. Participants must disclose any medical conditions, allergies, or mobility issues that may affect their participation in retreat activities.

7. Code of Conduct

7.1. Participants are expected to behave respectfully towards other guests, staff, and the local environment.

7.2. Any disruptive or inappropriate behaviour may result in removal from the retreat without a refund.

8. Liability Waiver

8.1. Participation in retreats is at the participant's own risk. Wanderfull Tales is not responsible for any injury, loss, or damage sustained by participants.

8.2. By booking a retreat, participants acknowledge that they participate at their own risk and release Wanderfull Tales from any claims related to injury or loss.

9. Content Usage Rights

9.1. Wanderfull Tales, together with the photographer and videographer, holds the rights to all professional content photographed and filmed during the retreat. This content may be used to promote future events.

9.2. If participants do not wish to appear on our digital platforms or have their images used for future promotional purposes, they must declare this in writing before registration.

9.3. Professional images taken during the retreat cannot be edited or altered with filters, except for automated crops required for social media dimensions.

10. Force Majeure

10.1. Wanderfull Tales is not liable for cancellations or changes due to unforeseen circumstances, including but not limited to natural disasters, pandemics, travel restrictions, or political instability.

11. Governing Law

11.1. Eleni Lioliou trading as Wanderfull Tales is registered as a sole trader in the UK and operates under UK law. Certain aspects of retreats may also be subject to local laws.

11.2. These Terms and Conditions are governed by and construed in accordance with the laws of England and Wales.

11.3. Any disputes arising from these terms shall be subject to the exclusive jurisdiction of the courts of England and Wales.
